This is a detailed specification of the Mastersizer 2000 describing the system and its capabilities and detailing pass/fail criteria which can form the basis of a User Performance Qualification.

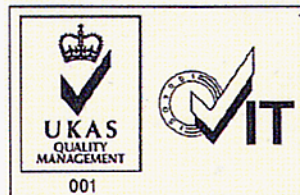
- 21 CFR Part 11 Feature Keys
